TERMS AND CONDITIONS:

I/We wish to bring the my/our craft/boat/vessel No. \_\_\_\_\_ [Boat] into RSYC (i.e. Club's) premises and enclose a copy of a valid MPA Craft License and Insurance Certificate. I/We declare and confirm that all information herein are true and am/are duly authorized by the owner of the above craft/boat/vessel to make this application/ declaration/agreement. If my/our application is approved, I/we agree to the following Terms and Conditions:

1. The License is for mooring the Boat and to use the Club's common area for access and egress to the Boat.
2. To pay all fees, charges, deposits and cost relating to the Boat. Berthing deposit will be forfeited if the 2-year license is not fulfilled or the license is not transferred as a new 2-year term to another member. Berthing rates (which I/we hereby acknowledge) will be computed according to the overall length of craft (including bowsprit, pulpit, swim platform, davit, engine, etc) measured by the Club's authorized persons.
3. The mooring of the Boat and use of Common Area is at my/our risk and the Club shall not be liable for any losses/damages claims cost or other liabilities arising from the mooring of the Boat, use of the Berth and Common Areas and related acts and services.
4. To comply with all reasonable orders/instructions from the Club relating to the Boat, use of the Club's facilities and the activities of my/our employees agent, invitees or otherwise at the Club's premises.
5. To observe, comply and ensure the compliance of the Marine By-laws (a copy of which I/we acknowledge) and all rules and constitution of the Club (available upon request) and to maintain and take reasonable precautions and do all things so as not to cause any damage and loss to the Club, its employees, members and invitees.
6. In the event of an emergency or for purposes of repair maintenance of the marina or both I/we agree that the Club reserves the right to move the Boat to another mooring place either within or outside the Marina.
7. Chartering of Boat is prohibited.
8. The Club has first and paramount lien over the Boat and its equipment to secure all moneys owing in the Club.
9. The Club shall not be responsible for any damage or loss howsoever caused including losses and damages arising from the launch or recovery of the Boat, the berthing and storage of the Boat or equipment and the sinking or breaking or drifting from the mooring of the Boat and any theft from and damage to the Boat. I/We agree to satisfy myself/ourselves as to the suitability, safety and reliability of the Club facilities and services and no warranty or undertaking or representation expressed or implied is given by the Club as to the state and condition or suitability or safety or otherwise of the facilities.
10. The Club shall not be liable for any death or injuries or both arising from the mooring launch recovery and otherwise of the Boat, or through the enjoyment of the Club its amenities, privileges or facilities on land or at sea or howsoever arising, including the death and injuries to my/our guest/ employees, contractors and invitees.
11. The Club shall not be liable for any loss or damage to any article, property or thing including loss from theft brought upon the Club premises.
12. The Club may terminate this license/arrangement by giving 24 hours prior notice (oral or written). Upon termination, I/we agree that we cease to be entitled to use the Club's facilities and to remove the Boat from the premises. If I/we fail to remove the Boat on the termination of this license/arrangement, the Club has absolute discretion to remove the Boat from the Club's premises.
13. I/We shall indemnify and keep indemnified the Club and its members against all losses, damages, claims, demands, actions, cost and other liabilities arising from and in connection with the mooring of the Boat and for ingress and egress through the common areas to the Boat and for all our/my acts, neglect or default or acts of our/my agents employees, contractors, invitees or any other person.
